#### 1. INTRODUCTION.

- 1.1 The Indian Railway Welfare Organisation (IRWO) has been set up as a registered society under the Societies Registration Act XXI of 1860 with its Headquarters at New Delhi, to provide dwelling units for serving and retired railway men at all India level purely as a social welfare measure on 'no-profit no-loss' basis.
- 1.2 IRWO had acquired land on lease at Borkheda, Kota (Rajasthan) about 4 km from main railway station. IRWO had launched its Rail Vihar Residential Scheme having about 167 independent plots. 113 Single-storied dwelling units of four types have been launched in Phase-I. The construction of these units is already in progress along with construction of common development works, namely, internal roads, water supply, sewerage, drainage and external electrification. Construction of a community center and park shall also be done.
- 1.3 Applications are invited from eligible applicants for sale of fifty four plots of land in Blocks A, B and C numbering from 1 to 54, in the above said residential complex. Land is on lease from Urban Improvement Trust (U.I.T), Kota, to IRWO. The sale of the plot of land on lease shall be by way of transfer of "Patta" from IRWO to the successful applicant, after permission from U.I.T, Kota.
- 1.4 For eligibility criteria, procedure for draw, allotment of dwelling units (read 'plots of land'), withdrawal from scheme, nomination and handing over etc. refer to IRWO's General Rules, April, 2013 as amended from time to time.
- 1.5 Besides IRWO members, following personnel are also permitted to apply for the allotment of plots. However, priority shall be given in the order indicated below:-
- (i) IRWO Members.
- (ii) Blood relations of IRWO Members viz. parents, spouse, children including adopted children, grand-children, brother (s) & sister(s).
- (iii) Working / Retired
  - (a) Employees of Central Government, Central Government PSUs, Statutory Authorities and Autonomous Bodies under Central Government.
  - (b) Army / Airforce / Naval Personnel.
  - (c) Employees of State Government, State Government PSUs, Statutory Authorities and Autonomous Bodies under State Governments.
  - (d) Employees of Nationalised Banks.
- 1.4.1 Spouses of blood relations can be Co-owners. Applications in respect of blood relations will have to be forwarded by the concerned IRWO member quoting the Primary Membership Number. In case more than one application is received from blood relations of an IRWO Member, he / she will have to specify the priority amongst these blood relations while counter signing the applications.
- 1.4.2 Applications in respect of other categories will have to be forwarded by their Controlling Officers.
- 1.4.3 Allotment both within the categories of IRWO members and within the categories of blood relations shall be based on seniority of IRWO members as per IRWO Rules.



- 1.4.4 For other categories allotment will be decided by draw of lots, if required.
- 1.4.5 Applicants (other than IRWO members) will also be required to become members of IRWO for this specific scheme before allotment of plot to them. For this they are also to send Membership Application form for the specific Scheme (in Annexure M attached) duly filled in.
- In relaxation of provision of para 15 of IRWO general Rules, IRWO members who have already been allotted two dwelling units may also apply for this Scheme. However, 1<sup>st</sup> time applicants will get priority over 2<sup>nd</sup> time applicants and so on. Similarly, among blood relations, 1<sup>st</sup> priority blood relations will get priority over 2<sup>nd</sup> priority blood relations (in case more than one blood relations of an IRWO member apply). Also allotment made to blood relations will not be considered as allotment to IRWO members. IRWO members will have 1<sup>st</sup> priority of allotment based on seniority of members as per IRWO rules. As a last option, vacant plot of land can also be offered for sale to Central and State Government PSUs, Statutory Authorities & Autonomous Bodies, Army / Air Force / Navy Personnel and Employees of Nationalised Banks.
- 1.6 The scheme will remain open from 22-05-2017 till all vacant plots are booked. Booking applications received in a month will be treated as one Batch and booking applications received during the period of each subsequent month will be considered as a separate Batch. The Scheme will be closed after entire vacant plots are booked and Wait List created.

#### 2. THE SCHEME.

- 2.1 The present scheme envisages sale of approved plots of land of two types, numbering from 1 to 54 in blocks A, B and C, to the applicants. Plot No. 35 is for Type-III 3BHK. All other plots are for Type-IV 3BHK or for Type-IV 4BHK.
- 2.2 Applicants may give their option for the plots of different types in the Application Form. Applicants shall deposit the Booking Money applicable for the type of plot opted by them.

#### 3. LOCATION.

- 3.1 The site is located at a distance of approximately 4 km from Kota Railway Station along the *nehar* road to Baran Road. The distance of site is about 1.5 km from the Railway Colony on one side and about 1 km from main Baran Road *Pulia*.
- 3.2 The key plan of location may be seen on back side of the back cover.

#### 4. TENTATIVE DETAILS OF PLOTS OF LAND.

4.1 Approximate area and approximate cost of 54 Plots are indicated in Table-1. It may be noted that the details of areas and cost are approximate and subject to actual measurement of area at site. The approximate cost of the plots is worked out based on the price of land at Rs.19,440/- per sq yd (=Rs.2,160/- per sq ft). This cost is fixed up to 31-08-2017, after which it is likely to be revised upwards.

- 4.2 Allotment and transfer of a plot to a successful applicant is subject to the following conditions.
- 4.2.1 Transfer of plot to successful applicant shall be done after due permission from U.I.T, Kota.
- 4.2.2 Actual cost of plot of land shall be as per actual area of the plot and payable accordingly by the allottee.
- 4.3.3. Construction work for dwelling unit on a plot shall be done as per approved layout plans of IRWO for the unit. Approved layouts for Type-III 3BHK, Type-IV 3BHK and Type-IV 4BHK are attached in this Brochure. Changes other than general façade, if desired by the allottee may be got approved by the allottee from U.I.T, Kota.
- 4.3.4. All charges towards registration, stamp duty, fees chargeable by the Deed Writer, etc, and fees for permission from U.I.T, Kota shall be borne by the allottee.
- 4.3.5. Provision of Park / Children's Play Ground, Community Centre, water supply, sewage disposal etc. is being made. Electric supply will be provided from / by Rajasthan State Electricity Board. Water supply and sewerage connection shall be given to the allottee from common services on payment of requisite charges as per expenditure and other connection fees leviable by U.I.T, Kota or state agencies.
- 4.3.6. Depending upon the number of applications received, allotment of plots shall be started from Block-C. Layout Plan of the plots offered is attached in the Brochure.
- 4.3.7. Any enhancement in cost / premium on land demanded by State Government for any reasons, shall also be payable proportionately by the allottees. The additional amount determined shall also be payable by the allottees within the period as specified by the concerned authorities.
- 4.3.8. There shall be additional cost towards corner plots, park(s) facing plots or any special feature attributed to a specific plot rates of which shall be as determined by IRWO after allotment of specific plot of land.
- 4.3.9. On receipt of application with booking money, booking letter with tentative instalments shall be issued. Specific allotment of plot will be made after the entire amount is deposited. Allottees will have the option to deposit the full cost



in less than six instslments.



4.3.10. After possession, resale of plots will be permitted to eligible persons as per para 1.5 subject to approval of U.I.T, Kota. After three years of possession, resale is permitted to any person subject to approval of U.I.T, Kota.

#### 5. HOW TO APPLY.

- 5.1 Three types of Booking Application forms are available in the Brochure for use by different categories of applicants:
  - (i) Annexure-1A for IRWO members.
  - (ii) Annexure-1B for Blood relations of IRWO members.
  - (iii) Annexure-1C for other categories.

Applications should be submitted in the application form as applicable to the applicant as per Annexure-1A, 1B and 1C to this Brochure (in duplicate) along with Annexures. Acknowledgement duly filled in, with booking money as given in the Schedule of Payment given in Annexure-II and should be sent to the Administrative Officer, Indian Railway Welfare Organisation, Shivaji Bridge, Behind Shankar Market, New Delhi- 110001. Application and Brochure can be downloaded from IRWO website <a href="https://www.irwo.net">www.irwo.net</a>.

- 5.2 Payment of Booking Money should be made by an A/c Payee Demand Draft or A/c Payee Banker's cheque in favour of "IRWO" Payable at New Delhi. Payment by cash will not be accepted.
- 5.3 Applicants other than IRWO Members are also required to send Membership Application Form (Annexure-M) duly filled in for this scheme.
- 5.4 The scheme is open from 22-05-2017 onwards and booking applications received in a month shall be treated as one batch (received within specified period). Similarly, booking applications received during each subsequent month shall be considered as separate batches, till the closing of the booking. Booking letters shall be issued for each batch at the end of the month based on seniority of the members of the batch. As such applications of second & subsequent batches will be considered only if plots of land are available after consideration of applications of the earlier batches.

#### 6. SCHEDULE OF PAYMENT.

- 6.1 On selection for allotment of a plot and issue of booking letter to the member, the member will be required to make payments in accordance with the Schedule given in Annexure-II. IRWO reserves the right to change schedule of payment depending upon the requirement of funds for work or any other reasons. Allottees shall be bound to abide by such revised schedule.
- 6.2 After issue of booking letter, the instalments 1 to 5 as given in Annexure-II, shall be paid by the allottees when these fall due. No separate intimation / letter will be issued as the details will be available in Booking Letter itself. Letter calling for the 6<sup>th</sup> and last instalment with the balance payable amount will be written to allottee and payment shall be made accordingly. However, no excuse for waiver of payment delay charges due to non-receipt of notice will be accepted as the information would also be available on IRWO website.



- 6.3 In case of delay of payment of any instalment of more than 7 days beyond the due date, delay charges @ 10.50% (Ten point five zero percent) per year will be charged extra, on monthly basis; part month of delay will be taken as full month delay.
- 6.4 If any allottee does not pay two consecutive instalments on due dates after issue of booking letter, a notice will be served to pay the instalments within 90 days with interest (delay charges). In case, the allottee does not make payments after having been served the notice about default in payment of instalment, a final notice would be served to him / her to make payment within 30 days. If the payment is not received by due date, his / her allotment will be liable to be CANCELLED and his / her booking money / instalment amount will be refunded after deducting the penalty amount as per Para 20 of IRWO General Rules.
- 6.5 Payment of booking money and last instalment will be accepted only through bank draft or banker's cheque drawn in favour of IRWO payable at New Delhi. Other payments may be made through local cheque / bank draft or Banker's cheque (drawn on Delhi / New Delhi Banks) in favour of IRWO subject to realization.
- 6.6 For payment of instalments, in case allottee needs financial assistance, he can apply for home loan to State Bank of Bikaner & Jaipur DRM Office Branch 10939, Kota after receipt of NOC from IRWO Office.

#### 7. IRWO GENERAL RULES 2013

- 7.1 For rules regarding registration, re-sale, transfer, withdrawal from the scheme, maintenance fund etc, please refer to IRWO's General Rules, April, 2013 and amendments made thereafter, a copy of which may be obtained by paying prescribed cost (at present Rs. 200/-) to the nearest IRWO's office or directly to the IRWO's Head Office at New Delhi. If required by post, please add Rs. 100/- to the cost indicated above. IRWO General Rules-April 2013 along with latest amendments can also be downloaded from IRWO's website: www.irwo.net.
- 7.2 Allotment of plots of land shall be done in accordance with the rules and laws of the local authorities in force as amended from time to time, as applicable.
- 7.3 Exracts of 'Para 20. WITHDRAWAL RULES', after booking a dwelling unit\*, from IRWO's General Rules, April, 2013, are given below:

#### \*Please read "plot of land" wherever dwelling unit is referred.

"20.2 Before Issue of Booking Letter (where wait-list does not exist)

In case of withdrawal after depositing booking money but before issue of Booking Letter, 50% of the booking money will be deducted. The balance will be refunded without interest. This will be, however, on submission of Undertaking as per Annexure- H2.

20.3 <u>After issue of Booking Letter but before Allotment of Dwelling Unit (where</u> wait-list does not exist).



In cases of withdrawal after issue of the confirmed Booking Letter but before allotment of the dwelling unit, full Booking Money plus 5% of instalments due (paid or not) up to the date of receipt of withdrawal letter plus interest due on delayed payment will be deducted and the balance paid without interest. This will be however, on submission of Undertaking as per Annexure H-2.

#### 20.4. After allotment (where wait-list does not exist)

In case of withdrawal after allotment but before possession of the dwelling unit, full Booking Money plus 7.5% of the instalment due (whether paid or not) up to the date of receipt of withdrawal letter plus interest on delayed payment will be deducted and the balance amount paid without interest. This will however be on submission of Undertaking as per Annexure H-2

In cases the withdrawal is because of the death of the Member before possession of the dwelling unit, if the spouse or the children (if the spouse is not alive), so desire full payment made by the member will be refunded without interest to the legal heir after deducting only administrative charges of Rs.2500 subject to legal formalities.

#### 20.5 After Possession

No withdrawal will be permitted after possession.

- 20.6 Where Waiting List exists such that the dwelling unit can be allotted to another applicant the penalty for withdrawal will be as under:-
- i) a) Before issue of Booking Letter Rs.2500/
  - b) After issue of Booking Letter:

```
Type I & II - Rs. 5,000/-
Type III & IV - Rs.10,000/-
```

- ii) In cases of withdrawal after three months from the date of issue of Booking Letter, an additional payment @ 9% per annum on the defaulted instalment is also payable. The total penalty, however, will not exceed Rs.10,000/- in case of Type I & II and Rs. 25,000/- in case of Type III & IV.
- iii) In case no person on the Waiting List accepts the offer, the case will be treated as with no Waiting List and dealt with as per para 20.3, 20.4 & 20.5 as applicable.
- iv) However, it is further provided that
- a) Actual refund will be made only after the dwelling unit is re-allotted and acceptance & undertaking received from the new allottee, duly signed.
- b) The new allottee shall pay to IRWO the cost of the dwelling unit plus an equalization charge as if he is a new entrant to the scheme."
