



CONDITIONS:

- 1) All the Election Proceedings shall be held in the RWA Office of Rail Kunj Moradabad.
- 2) Only those Allottee Members who are residing in Rail Kunj, Village Manoharpur, Delhi Road, Moradabad and Cleared all Dues of IRWO till date are eligible to contest for the post of Office Bearers for which the elections are being held, also subject to their not holding of any post of Office in any other Housing Society/RWA.
- 3) Only the Original Allottee who has taken possession of his Dwelling Unit and member of the proposed RWA in Rail Kunj, Village Manoharpur, Delhi Road, Moradabad is eligible to cast the Vote.
- 4) Nominations shall be accepted in the prescribed forms within the stipulated date and time.
- 5) **Every nomination is to be proposed by one Resident Allottee and seconded by another resident allottee of Rail Kunj Moradabad.**
***Resident Allottee: means an allottee living in his Dwelling Unit.**
- 6) Voting by "PROXY" and Postal Ballots are not Permitted.
- 7) At the time of voting, every voter must bring with him/her the Original Possession Letter issued by IRWO (which contains the Photograph and specimen signatures). In exceptional cases, in the absence of an Original Possession Letter, other proof of identity may be accepted on the discretion of the Returning Officer.
- 8) Co-allottee is not eligible to vote.
- 9) (i) A contestant can propose another candidate for another post of office bearer.
(ii) One Proposer can propose more than one candidate for different posts of office bearers.
(iii) One Secunder can second more than one candidate for different posts of office bearers.
- 10) In case of any dispute, the Returning Officers' decision shall be final and binding on all concerned.
- 11) Copy of the Performa for NOMINATION is enclosed.
- 12) In case lesser nominations for executive Members are received than the proposed posts, the election will be held for the post for which nominations have been received. Balance posts can be filled by nomination by the elected members.
